## IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

- 1. The Stipulation is approved.
- 2. Notwithstanding any provision of the Bankruptcy Code to the contrary, including, without limitation, sections 362, 363, and 549 of the Bankruptcy Code, subject to Hanmi satisfying the Draw (as defined in the Stipulation), Hanmi shall be permitted to liquidate the CD (as defined in the Stipulation) and apply \$1,850,000.00 of the CD proceeds in full, complete and final satisfaction of the Beverly Community Hospital Association's obligations under the Note (as defined in the Stipulation), with any remaining amount of such proceeds to be remitted at the direction of the Trustee.
- 3. Nothing in the Stipulation or this Order shall alter or affect the rights of the Trustee with respect to the funds transferred to the Beneficiary (as defined in the Stipulation).
