By the Motion, the Debtors further requested that at the Sale Hearing, subject to the results of the Auction, this Court enter a sale order (i) approving and authorizing the Sale; and (ii) authorizing the assumption and assignment of certain Executory Contracts and Real Property Leases.

PLEASE TAKE NOTICE THAT on July 17, 2012, the Court entered the Order (A) Establishing Bidding and Auction Procedures Related to the Sale of Substantially All of the Debtors' Assets; (B) Establishing Procedures for Approval of Related Bid Protections; (C) Scheduling an Auction and Sale Hearing; (D) Establishing Notice Procedures for Determining Cure Amounts for Executory Contracts and Leases to Be Assigned; and (E) Granting Certain Related Relief [Docket No. 618] (the "Order") which among other things, approved the Proposed Notice Procedures for the assumption and assignment of Executory Contracts and Real Property Leases. Pursuant to the Order, the Debtors are required to file with the Court a list of Executory Contracts and Real Property Leases that were assumed and assigned to the Successful Bidder as of the closing date of the Sale (the "Closing Date").

PLEASE TAKE FURTHER NOTICE that on September 11, 2012 the Court entered the Order (A) Approving the Sale of Substantially All of the Debtors' Assets Free and Clear of All Liens, Claims, Encumbrances and Interests; and (B) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases [Docket No. 758] (the "Sale Order") which identified Scepter Holdings Inc. as the Successful Bidder for the Assets (the "Purchaser").

PLEASE TAKE FURTHER NOTICE that the Closing Date occurred on September 28, 2012.
