Preamble

AHA is an integrated training centre for helicopter pilots, emergency physicians and HEMS paramedics, offering piloting skills training programmes and medical education or advanced training on the AHA premises and its facilities in Sankt Augustin to national and international customers. In addition, AHA provides related ancillary services.

Customer shall benefit from the conditions and covenants stipulated in this Master Contract which shall be the basis of all bookings by Customer.

NOW THEREFORE the parties hereto agree as follows:

§ 1 Object of the Contract

1. The object of this Master Contract is licensing the use of the helicopter simulators below by Customer at the AHA Sankt Augustin facility.

- The parties shall stipulate an annual minimum volume of simulator hours. The annual minimum usage, if any, and any special agreements shall be set forth in Appendix 1. One simulator hour shall be equivalent to 60 real time minutes, counting from the first trainee stepping into the simulator.
- 3. In addition to making the helicopter simulator available, AHA shall render the additional services set out in Appendix 1.
- 4. As a rule, AHA services shall not include the provision of flight instructors (i.e. dry lease), unless otherwise expressly stipulated.

§ 2 Booking of simulator capacity and confirmation

- Customer shall be free to use the annual volume agreed in Appendix 1 subject to AHA's operating times, Monday through Friday (except for public holidays in North Rhine-Westphalia) between 08:00 and 20:00 hours local time. The parties may agree any other times of use on a case-by-case basis as set out in Appendix 1 if required.
- Customer shall place all booking requests whether oral or written (fax, email) quoting the Contract Number using the following AHA contact data:

- 3. AHA shall confirm all oral, written or online bookings placed by Customer in writing. Bookings shall not be considered as binding unless so confirmed in writing. Where the requested dates/times are not available, AHA shall suggest and agree alternative dates/times with Customer. Booking requests shall be placed no later than 3 days before the scheduled start of training.
- 4. In addition, AHA shall enable Customer to access the online booking tool and directly book the desired simulator times.
- 5. Where Customer for reasons beyond AHA's control fails to appear in time before the scheduled start of training, no extension of training time may be claimed.

§ 3 Terms and conditions

- 1. The fees per simulator hour shall apply as set forth in Appendix 1.
- 2. Prices for the annual volume agreed under Appendix 1 shall be discounted at the stipulated in-house rates.

The discount shall refer to one calendar year (1 January to 31 December). Where no full calendar year is covered, the discount shall be calculated as follows:

1/12 x annual volume (h) x contract term in months per calendar year.

Example:

 $1/12 \times 100h \times 7$ months = $58h \rightarrow$ basis for 5% discount if the Master Contract runs from 1 January xx to 31 July xx in any one calendar year.

If Customer fails to use the annual volume agreed within any one year, the discount of the actual volume used shall apply and AHA shall subsequently invoice the balance. If Customer exceeds the annual volume agreed, the next higher discount shall apply and AHA shall subsequently credit the balance to Customer.

- 3. Discounts shall not apply to training other than simulator training, nor to catering, hotel accommodation or other leasing and staff costs.
- 4. AHA shall separately invoice for any instructors made available to Customer.

§ 5 Term

- 1. This Master Contract shall commence on 01.06.2012 and run until 31.05.2013 (fixed term). It shall renew automatically for successive one-year terms, unless it is terminated by giving 6 months notice to the end of the fixed term or any successive one-year term.
- The parties shall be entitled to prematurely terminate this Master Contract with immediate effect for good cause. Good cause shall include, but not be limited to
 - a) the other party's continuing failure to comply with the obligations hereunder despite prior written notice allowing a reasonable period of time; and cases where
 - b) a petition was filed by or against the other party under the insolvency act or any amendment thereof.
- 3. Any notice of termination shall be given in writing.

4. In the event of the Master Contract's termination and ongoing validity of individual agreements (e.g. outstanding booked simulator hours), if any, the master conditions shall continue to apply to individual agreements in force.

§ 6 Liability

AHA shall not be liable for any damage in respect of personal injury, unless such damage was caused by a wilful act or the gross negligence of AHA or any of their legal representatives or employees, servants or agents.

AHA shall not be liable for any other damage unless such damage was caused intentionally or by gross negligence by AHA or any of their legal representatives or employees, servants or agents. This limitation of liability shall not apply in the event of material breach. In the event of negligent material breach by AHA and/or any of their legal representatives or employees, servants or agents, liability shall be limited to the extent of the foreseeable damage as is typical for this type of loss.

§ 7 Advertising

No pictures, labels or posters shall be attached inside the simulator.

§ 8 Confidentiality and data protection

- Customer shall permit AHA to save and process personal data exclusively for the provision of services hereunder.
- 2. In addition, the provisions on confidentiality and data protection set forth in No. 10 of the General Terms and Conditions (Appendix 3) shall apply.



§ 9 Customer rules of conduct

Customer shall handle the helicopter simulator with due care and report any damage to the helicopter simulator without delay.

Customer shall comply with AHA House Rules (Appendix 2) and shall ensure that its trainees are aware of and act in accordance with such rules.

The helicopter simulator shall be used only within the normal operating limits of the relevant helicopter model.

Procedures, which have to be demonstrated and trained temporarily within the safety procedure training (e.g. auto rotation to the ground, flight in icing conditions, flight above VNE, retreating blade stall, vortex ring state, etc.) are excluded from that restriction.
