**NOTICE OF WITHDRAWAL OF CERTAIN OBJECTIONS TO CLAIMS MADE IN THE
SEVENTH OMNIBUS OBJECTION TO CLAIMS PURSUANT TO
11 U.S.C. § 502(b) AND FED. R. BANK R. P. 3007**

1. Turnaround Advisors, L.L.C., as liquidating trustee (the "Trustee") of the Eos Airlines Inc., Liquidating Trust (the "Trust"), created pursuant to the joint plan of liquidation, dated December 18, 2008 (the "Joint Plan"), confirmed by order, dated January 28, 2009 (the "Confirmation Order"), filed with the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court"), the Seventh Omnibus Objection to Claims (the "Seventh Omnibus Objection") (Docket No. 509) on January 15, 2010.
2. On March 5, 2010, the Court entered an Order (Docket No. 537) adjourning the hearing on the Seventh Omnibus Objection to April 9, 2010 (the "Adjourned Hearing") with regard to the Claims¹ of customers with the identifying numbers of: C0151181, C01163553, C01163564, C0148941, C0177276, C01138110,

C01112991, C0172870, C0129783 (also filed as Claim #793), C01123561
(collectively the "Adjourned Claims").²

3. At the Adjourned Hearing, Counsel for the Trustee announced that the Trustee is withdrawing its Seventh Omnibus Objection solely with regard to the Adjourned Claims. This notice (the "Notice") hereby memorializes such withdrawal, and does not relate to any claims beyond the Adjourned Claims.
4. This Notice is without prejudice to the Trustee's right to amend, modify or supplement the Seventh Omnibus Objection, to object to any Adjourned Claims on any grounds in future objections to Claims, to bring an action against any holder of an Adjourned Claim under Chapter 5 of Title 11 of the United States Code, or to object to any other Claims or interests filed in this Chapter 11 case.
