Liquidity and DIP Draw

Mr. Healy provided an update on the Company's liquidity and request to draw ("DIP Draw") on the Company's debtor in possession finance facility. Mr. Healy reported on the Company's cash receipts and operating disbursements relative to forecast. Mr. Healy discussed the liquidity requirements and mechanics for requesting a DIP Draw and the timing considerations related thereto. Questions were asked and a discussion ensued regarding the timing of the DIP Draw, the potential impact of negotiations with the ad hoc group of the Company's secured lenders (the "Ad Hoc Group") on the DIP Draw, and the importance of timely requesting the DIP Draw to mitigate risk to the Company's liquidity position.

Chapter 11 Update

Mr. Waldman referred to the Materials and provided an overview of the key terms of the "Restructuring Term Sheet". Mr. Waldman referred to the redline of the Restructuring Term Sheet contained in the Materials reflecting comments from the Company's advisors and discussed the economic proposals contained therein. Mr. Griffiths advised

Questions were asked and a discussion ensued regarding the terms of the Restructuring Term Sheet and strategic considerations for negotiating the terms with the Ad Hoc Group.

Management Incentive Plan

Mr. Shaper reported on recent conversations with Black Diamond Capital Management and Centerbridge Partners regarding the terms of a management incentive plan ("MIP"). Mr. Wilks discussed the SRC's intent to support management's negotiations of a MIP and a discussion ensued regarding the process and industry standards for negotiating a MIP in chapter 11, and the role of the Company's restructuring advisors in such negotiations, and the potential for management to retain third-party advisors to represent its interests in connection therewith. Further discussion ensued

Ex-CEO Payment Obligation

Mr. Wilks reported that Mr. Beylier granted the Company an extension of time to respond to the settlement proposal set forth in Mr. Beylier's letter dated 5 June 2020. Mr. Griffiths reported that Herbert Smith Freehills and Weil were communicating with advisors to the Official Committee of Unsecured Committee and the Ad Hoc Group regarding next steps and strategic options related thereto.

II. DISCUSSION

Following introductory remarks, and confirmation that the agenda annexed hereto as Exhibit 1 (the "<u>Agenda</u>") was circulated to the SRC, Mr. Griffiths took the SRC and those present through the Agenda. Ms. Morrison recorded the minutes.

Board Composition and ASX Announcement

Mr. Griffiths reported that Mr. Shaper and Mr. Spytek had resigned from the Board of the Company and a discussion ensued regarding the forthcoming ASX release.

Business Update

Messrs. Shaper and Spytek provided the SRC with an update on the Company's business performance. Mr. Spytek reported that the Company was investigating an alleged Foreign Corrupt Practices Act ("FCPA") breach in the Philippines, and the employees implicated in such investigation. Following discussion, the Company reported that it would revert with a recommendation for a path forward regarding the FCPA investigation. Mr. Shaper provided an update regarding the recent IT incident, including that the Company had approximately 25% of its internal systems operating, and that the incident was impacting employee morale. Mr. Myers reported that the Company was continuing to stabilize its internal IT systems and believed that the situation was now under control, but noted that there would likely be delays in financial reporting due to the incident.

Messrs. Shaper, Spytek, Gyngell, and Meyers left the meeting at approximately 10:15am (AEST).

Chapter 11 Update

Mr. Griffiths then addressed the negotiations between Black Diamond Capital Management ("BDCM") and Centerbridge Partners ("Centerbridge") regarding their respective chapter 11 plan proposals (each, a "Proposal") and reported that there were no material changes since the prior SRC meeting.

Mr. Griffiths reported on Weil's discussions with Centerbridge, including that the Company had advised Centerbridge that, subject to binding documentation being finalized with BDCM, the BDCM Proposal was likely to be considered higher and better than the Centerbridge Proposal by the Company and the SRC.

Mr. Griffiths also reported on discussions with BDCM, including that the Company had asked BDCM to deliver governance terms with sufficient detail to enable the Company to further refine its analysis of the BDCM Proposal.

A discussion ensued regarding Centerbridge's willingness to increase their current Proposal in light of the BDCM Proposal and whether the Official Committee of Unsecured Creditors in the Company's chapter 11 cases would support the BDCM Proposal based on the proposed recoveries to general unsecured creditors.

Ms. Flaton then asked whether the competing Proposals would impact the upcoming hearing for limited relief related to the Equity Commitment Agreement, dated August 12, 2020, with Centerbridge (the "ECA"). A discussion ensued and the SRC agreed that the Company would work with BDCM to achieve a firm Proposal before withdrawing the ECA motion.

Employee Matters

Mr. Wilks reported that Joe Spytek had delivered a letter rescinding his resignation, and a discussion ensued regarding his future role with the Company.

Mr. Wilks also discussed the Company's decision to accept Mr. Shaper's resignation. Mr. Wilks gave an outline of the press release to be issued regarding Mr. Shaper's resignation, and the process for formalizing the Company's acceptance of Mr. Shaper's resignation.

DIP Upsizing & Liquidity

Mr. Myers discussed the anticipated additional funding required by the Company under its debtor in possession ("DIP") financing budget and reported on the Company's performance compared to forecast. Discussion ensued regarding communication of the Company's funding needs with Black Diamond Capital Management ("BDCM") and Centerbridge Partners ("Centerbridge"), and the factors contributing to the DIP upsizing need. Further discussion ensued regarding the Company's funding requirements and the impact of various timing, operational and transaction implementation scenarios.

Business Updates

Mr. Wilks reported that the Company had lost business from Transocean to a competitor and discussed the reasons for the loss, including the Company's extended restructuring timeline. Discussion ensued regarding ensuring that a clear message was developed for the Company's customers regarding the restructuring process and the Company's anticipated exit from chapter 11.

Plan Sponsor Update & Strategic Considerations

A discussing ensued regarding the terms of the latest BDCM chapter 11 plan proposal ("BDCM Proposal"). Mr. Holtzer discussed the terms of the BDCM Proposal and its relation to the Company's postpetition debtor-in-possession financing facility (the "DIP Facility").

Mr. Holtzer then addressed the status of the valuation analysis that was being prepared to ensure a rigorous analysis of the various proposals before the SRC.

Discussion ensued regarding the potential for a settlement between BDCM and Centerbridge, the prospect of Centerbridge buying-out BDCM's debt position, and the need for additional information and governance terms in connection with the BDCM Proposal.

KERP & KEIP

Mr. Healy reported that FTI and the Company were developing a list of potential participants in a key employee retention program ("KERP") and key employee incentive program ("KEIP"), and a discussion ensued regarding the number of employees contemplated to be included in such programs and the timing for filing motions to approve each. After discussion, the


