JOINT STIPULATION AND AGREED ORDER REGARDING INTERNAL REVENUE SERVICE'S PROOFS OF CLAIM

The Department of Treasury – Internal Revenue Service (the "**IRS**") and SpeedCast Americas, Inc. and Maritime Communication Services, Inc. (together, the "**Reorganized Debtors**"; and collectively with the IRS, the "**Parties**") hereby enter into this *Stipulation and Agreed Order* with respect to the extension of the deadline for the Reorganized Debtors to object to the remaining unresolved claims asserted by the IRS against the Reorganized Debtors (the "**Claim Objection Deadline**") and stipulate and agree as follows:

WHEREAS, on June 27, 2023, the Court entered the *Joint Stipulation and Agreed Order Regarding Internal Revenue Service's Proofs of Claim* (Docket No. 2046), extending the Claim Objection Deadline for the Proofs of Claim to December 31, 2023;
