
**NOTICE OF HEARING
ON APRIL 21, 2022 AT 9:30 A.M. (CENTRAL TIME)**

PLEASE TAKE NOTICE that on March 7, 2022, SpeedCast International Limited and its debtor affiliates in the above-captioned chapter 11 cases, (as reorganized, the “**Reorganized Debtors**”) filed the *Reorganized Debtors’ Motion for Entry of Final Decree Closing Certain of the Chapter 11 Cases* (ECF No. 1908) (the “**Motion**”).

PLEASE TAKE FURTHER NOTICE that on March 30, 2022, the Reorganized Debtors filed the *Amended Certification of Counsel Regarding Reorganized Debtors’ Motion for Entry of a Final Decree Closing Certain of the Chapter 11 Cases* (ECF No. 1913).

PLEASE TAKE FURTHER NOTICE that a hearing to consider the Motion will be conducted Honorable Marvin Isgur, United States Bankruptcy Judge, on **April 21, 2022 at 9:30 a.m. (CST)**, in Courtroom 404, 4th floor, 515 Rusk, Houston, TX 77002. You may appear for the Hearing either in person or by remote participation via an audio and video connection. Audio communication for the Hearing will be by use of the Court’s dial-in facility. You may access the

To use GoToMeeting, the Court recommends that you download the free GoToMeeting application prior to the Hearing. To connect, you should enter the meeting code "JudgeIsgur". You may also view video by visiting www.gotomeeting.com, selecting "Join," and then entering meeting code "JudgeIsgur". You may also connect directly to the GoToMeeting platform by clicking the link on Judge Isgur's home page. Hearing appearances must be made electronically in advance of the Hearing. To make your appearance, click the "Electronic Appearance" link on Judge Isgur's home page, select the case name, complete the required fields, and click "Submit" to complete your appearance.

PLEASE TAKE FURTHER NOTICE that any objecting parties are required to attend the Hearing, and failure to appear may result in relief being granted upon default.
